- Completed Application**. It is important that the form be filled out neatly and be completed in ink or typed.
- Resume** of extracurricular activities, including employment (if any), clubs, volunteer activities, and sports teams. Please include an appropriate picture of yourself for reference.
- Essay/Personal Statement**. Limit your writing to 500 words. Prompt included in packet.
- Official Transcript**. Please include the most recent grades available. You are welcome to submit transcripts for any college work that you have completed.
- An official copy of your ACT and/or SAT scores**.
- Affidavit of residence & media release form**
- Three letters of recommendation**. Letters of recommendation may come from teachers, guidance counselors, coaches and/or employers. It is recommended that at least one letter come from a science or math teacher. Letters from family members will not be accepted.

Please see the information below for general information, requirements, and guidelines regarding the nomination process.

Thank you for your interest in obtaining a nomination to a U.S. Service Academy. The honor of attending a service academy comes with the obligation and commitment to serve in the military for a minimum of five years upon graduation.

Members of Congress may nominate candidates for appointment to four of the five U.S. service academies:

United States Military Academy (USMA), West Point, NY; the United States Naval Academy (USNA), Annapolis, MD; the United States Air Force Academy (USAFSA), Colorado Springs, CO; and the United States Merchant Marine Academy (USMMA), Kings Point, NY. (Note: The fifth service academy, the United States Coast Guard Academy (USCGA), New London, CT, does not require a congressional nomination for appointment.)

Congressman Levin may nominate up to ten individuals for each vacant academy slot allotted to our district. To request a Military Academy Nomination from our office, please submit a complete application packet. Best wishes to you as you pursue your goal of attending a United States Service Academy and serving our country.

I. Minimum Nomination Requirements

To apply for a nomination to the **Air Force, Military, Naval, or Merchant Marine Academies**, you must meet all the following minimum requirements:

- be a U.S. citizen or national
- be at least 17 years old and not yet 23 years old on July 1 of the year the applicant would enter the academy (25 years old for USMMA)
- be unmarried, not pregnant, and without legal obligation to support children or other dependents
- demonstrate comprehensive academic preparation
- demonstrate leadership in athletics or other extracurricular activities
- take the SAT or the ACT
- be in good physical and mental health (the academies require a comprehensive medical exam and physical aptitude exam before acceptance)

Note: The U.S. Coast Guard Academy does not require a congressional nomination for appointment.

II. Application Requirements

To be considered for a nomination to a United States Service Academy, the completed application together with ALL supporting materials must be received in Rep. Levin's District Office by 5:00 p.m. Monday, October 21, 2024. Because nominations are highly competitive, you are encouraged to apply for nominations with additional offices, including those of President Biden, Vice President Harris, Senator Butler, or Senator Padilla.

Standardized Testing: A copy of your Scholastic Assessment Test (SAT) and/or American College Testing (ACT) scores is required.

NOTE: The results of the autumn SAT and ACT may arrive too late for consideration in your application.

Transcript(s): An official high school transcript must be included with your application materials. The transcript must list your senior year courses. Please also provide a transcript for any college work that you have completed.

Letters of recommendation: Three letters of recommendation. Letters of recommendation may come from teachers, guidance counselors, coaches and/or employers. At least one letter must come from a science or math teacher. Letters from family members will not be accepted. All letters must be signed and submitted in sealed envelopes.

- Your recommender(s) may prefer their letter be sent directly to our office. If that is the case, they may send their letter directly to CA49.ServiceAcademy@mail.house.gov with the subject line "Candidate Name – Letter of Recommendation"

Service Academy Advisory Board Interviews. Each qualified applicant will be interviewed by Rep. Levin's Service Academy Advisory Board in **Fall 2024**. Qualified applicants who submit a completed application by **5:00 p.m. Monday, October 21, 2024**, will be notified of their interview appointment time.

Your completed application: Please send your completed application to Rep. Levin's District Office. Use the application checklist to ensure that your application is complete. An application is considered complete only if it includes ALL the required items, as specified on the checklist on page #1.

Interview Process

Congressman Levin has appointed a Service Academy Nominations Advisory Panel which will conduct the interview process. Our nominations advisory panel includes educators, service academy alumni, representatives of veterans' groups, and other community leaders from the district.

Interviews will be conducted in November. We will be happy to accommodate requests for applicants who anticipate difficulties in scheduling.
